# 2023 LEGISLATIVE WRAP-UP

## United for a Safe & Prosperous Community

**The United Way of Southeast Louisiana Public Policy 2023 State Legislative Agenda, United for a Safe and Prosperous Community**, continues to advance our fight to eradicate poverty in Southeast Louisiana through the [Blueprint for Prosperity](#) and support [ALICE](#) (Asset Limited, Income Constrained, Employed) households. ALICE represents the growing number of hardworking individuals and families across our state who are employed but unable to afford the basic household necessities (including housing, child care, health care, food, and transportation) that undergird economic stability. According to the United Way ALICE Report, over half of our state's households live in poverty or struggle to make ends meet, a reality whose implications have become more apparent following the coronavirus pandemic and recent major weather events.

UWSELA Public Policy team coordinated with our Community Impact experts to ensure we included issues resonating in our community and affecting ALICE families in this agenda. Our agenda was also informed by the needs highlighted by residents in each of the seven parishes we serve (Jefferson, Orleans, Plaquemines, St. Bernard, St. Tammany, Tangipahoa, and Washington) in our Community Conversations series and is responsive to the challenges most pressing to our communities.

UWSELA Public Policy Committee met before the start of the session to prepare our 2023 State Legislative Agenda. This year we held four Educational Sessions to help engage our collaborative partners and funders, which included subject matter experts who shared their knowledge to assist us in creating a robust agenda. **Mary Ambrose, UWSELA Chief Equity & Impact Officer, kicked off each educational session with the following DEI question:**

*"So often policies are created without community input, causing harm, especially to the same communities they are intended to help. **How are you ensuring you are putting people first – focusing on real people's problems and experiences to uncover and address systemic inequities?"***

## 2023 EXTRAORDINARY SESSION

The Louisiana Legislature held its first Extraordinary Session this year to address Insurance Commissioner Jim Donelon's request to allocate \$45 million to a newly-created incentive fund to attract insurance firms to Louisiana. The Legislature passed ACT 1 (formerly HB 1) by Rep. Jerome Zeringue, which appropriated \$45 million to the Insure Louisiana Incentive Program to incentivize insurance companies to write policies in Louisiana. ACT 2 (formerly HB 2) by Rep. John Stefanski was also passed, which restricts the use of funding for the Insure Louisiana Incentive Program. Under HB2, no insurance provider that filed for bankruptcy or was declared insolvent will be eligible for financial incentives.

## 2023 REGULAR LEGISLATIVE SESSION

The 2023 Regular Legislative Session convened on April 10 and adjourned at approximately 6:00 p.m. on June 8. This year's Louisiana Legislature had record revenue available to address Louisiana's many needs.

Odd years are limited fiscal sessions. Legislators could file unlimited fiscal bills, unlimited local bills, and only five general bills. Instruments filed included: 894 bills (661 House bills and 233 Senate bills), 29 constitutional amendments, and 723 resolutions and study requests.

Total Fiscal Year 23-24 Appropriations equaled \$50.9B. The Balanced State Budget for Fiscal Year 2023-2024 included the General Appropriation Bill (HB 1), which contained \$43.7B for the ordinary operating expenditures of the executive branch for FY23, an \$113.6M increase over FY22.

SCR 3 increased the expenditure limit for FY23 by \$250M and FY24 by \$1.4B allowing the Legislature to appropriate additional state revenue recognized by the Revenue Estimating Conference (REC).

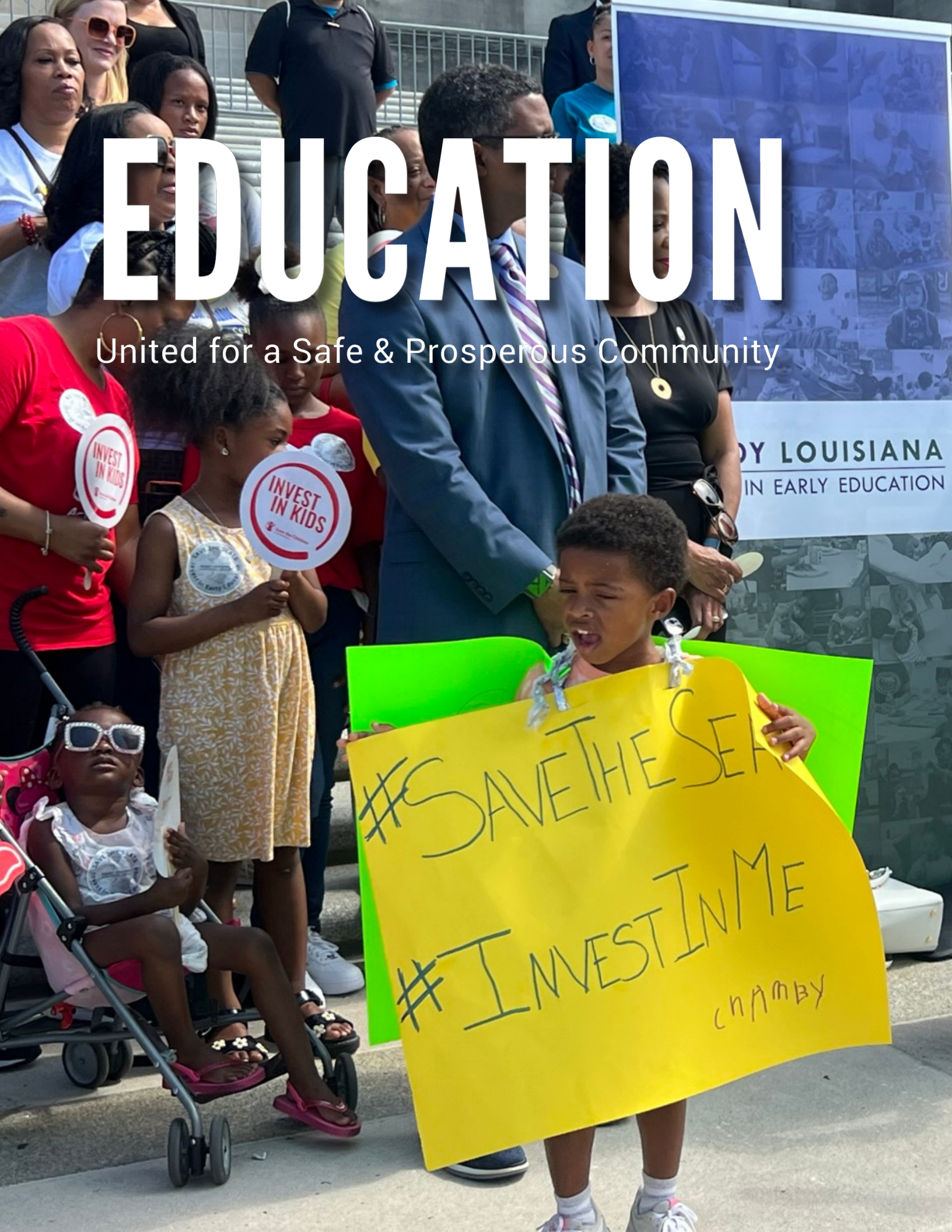
## 2023 VETO SESSION

Gov. John Bel Edwards vetoed 25 2023 Regular Legislative Session bills, including the [state budget](#) and LGBTQ+ identity. Gov. Edwards' veto of a ban on gender-affirming medical care for trans youth triggered a veto-override session in July. The five-day special session of the Louisiana Legislature ended after one day, in a score of Gov. Edwards 24, Legislature 1.



# EDUCATION

## The 2023 Legislative Session was a success.

Your support made it possible for United Way of Southeast Louisiana, the Ready Louisiana Coalition, and our collaborative partners to advocate for funding and policies that support young children and their families.

This year, we are walking away with almost \$52 million in new funding for young children in HB 1, the largest state investment of state dollars into the Child Care Assistance Program in over a decade. When session ended, there was \$44 million in the budget, but thanks to a line item veto by Governor Edwards, we now have almost \$52 million total going into early care and education (ECE). As a result of our tireless, collaborative efforts, approximately 4,000 children across the state will keep their publicly-funded ECE seats.

In addition to increased ECE investment, the Legislature passed three critical pieces of legislation that support children and their families:

- Representative Barbara Freiberg's HB 338 modifies the duties of the Early Childhood Care and Education Commission and requires them to look at a formula to fund ECE.
- Representative Ken Brass' resolution HCR 43 urges and requests the Department of Education to update its ECE data management systems as soon as possible.
- Senator Sharon Hewitt's bill SB 201 requires the use of technology when conducting public meetings to facilitate participation for those who find it difficult to attend in person but whose experiences would improve the process. This will allow parents of young children to participate in the public meeting process regardless of access to childcare.

We are proud to have advocated for these wins, which are excellent steps in the right direction toward ensuring Louisiana children are prepared for success, parents are supported, and employers have a reliable workforce.



Ready Louisiana hosted the Early Education Day 2023 at the Capitol in the Governor's Press Room, followed by a successful luncheon at Lt. Governor Billy Nungesser's apartment in the Pentagon Barracks. UWSELA, LPIC, and the entire Ready LA coalition educated policymakers about the importance of improving policies and increasing investment for quality early care and education for children birth through age four in Louisiana.



The Louisiana Policy Institute for Children (LPIC), in partnership with UWSELA, held a press conference at the Louisiana State Capitol to release a report, funded with support from Entergy Corporation, "[A Modern History of Early Care and Education in Louisiana](#)," which analyzed the modern history of early care and education (ECE) in legislation and funding from the turn of the 21st century through 2022, including lessons learned.

## OTHER EDUCATION LEGISLATION

UWSELA advocated for governmental action in the wide range of supports necessary for young people to pursue meaningful and fulfilling futures, including early childhood, K-12 educational policies, and higher education, protecting the rights and well-being of students, and investment in educational professionals to enhance student achievement and well-being.

UWSELA encouraged increased governmental support for evidence-based programs and policies that undergird economic stability and financial empowerment for all, including workforce development, pay transparency, emergency assistance, and the establishment of a living wage. We monitored legislation that would hinder positions we have taken in the past that may further negatively impact our ALICE community.

# HEALTH

**UWSELA inspired governmental action to ensure that all Louisianans have access to equitable health services that protect and improve mental and physical well-being,** including trauma-informed care, mental health services, paid family leave, Medicaid, maternal child health, services for sexual assault survivors, and human trafficking prevention.

UWSELA committed investment in the [Whole Health Louisiana](#) (WHL) initiative, a multi-sector, statewide effort from First Lady Donna Edwards' office to prevent childhood adversity and trauma and address the short- and long-term impacts of adversity and trauma on children, families, and communities. Louisiana ranks in the top 10 of the worst states with the highest per capita number of children (birth to 17 years) who have experienced two or more Adverse Childhood Experiences (ACEs): 18.6% in Louisiana compared to the 14.0% U.S. average ([National Survey of Children's Health](#), 2020-21). Public Policy Chair, Ron McClain is appointed as UWSELA's member on the WHL Steering Committee.

The Louisiana Senate leadership included an additional \$7 million for domestic violence shelters and victims' services in its state budget proposal.
