PROPOSED 2024 STATE LEGISLATIVE AGENDA "UNITED FOR A SAFE & PROSPEROUS COMMUNITY"

The **2024 First Extraordinary Session** was held January 15th and adjourned January 19th. Governor Jeff Landry signed the following legislation into law:

ACT 2 (SB 8) by Sen. Glen Womack - https://www.legis.la.gov/legis/ViewDocument.aspx?d=1340757 CONGRESS: Provides for redistricting of Louisiana congressional districts. (Item #1)(See Act) (EN INCREASE GF EX See Note)

• ACT 2 - A map creating a second majority-Black congressional district, passed in the Louisiana Legislature after a week of the Redistricting Special Session. The state was granted a final opportunity to pass a map before the deadline of the Federal court trial of Robinson v. Landry.

The **2024 Second Extraordinary Session** convened on February 19th with final adjournment no later than 6:00 pm on March 6th. This second special session is focused on tackling the issue of crime. https://house.louisiana.gov/Agendas 2024/Governor's%20Call%202024%202nd%20ES Final.pdf

The 2024 Regular Legislative Session will convene at noon on Monday, March 11th with final adjournment no later than 6:00 pm on Monday, June 3rd.

According to the United Way ALICE Report, over half of households in our state are living in poverty or struggling to make ends meet.
